#### DEPARTMENT OF DESIGN VOTING PROCEDURES, 10/12/14

#### 1. MERITS, PROMOTIONS, APPRAISALS:

All non-emeriti/ae Academic Senate faculty members within the Department of Design participate in personnel deliberations and vote (with the exception of their own actions).

2. APPOINTMENTS TO NEW FACULTY POSITIONS AT ANY LEVEL, TO JOINT PROFESSOR POSITIONS AT ANY LEVEL, AND TO VISITING LECTURER AND PROFESSIONAL RESEARCH POSITIONS:

All non emeriti/ae Academic Senate faculty within the Department of Design have voting privileges.

#### 3.DEFERRALS:

No vote is taken. The dept. chair will decide on the appropriate action per procedure in APM UCD-220, Procedure 2.

#### 4. FIVE YEAR REVIEWS:

All non-emeriti/ae Academic Senate faculty members within the Department of Design participate in personnel deliberations and vote.

# 5. INTERDEPARTMENTAL TRANSFERS AND PHASED RETIREMENTS:

All non-emeriti/ae Academic Senate faculty members within the Department of Design participate in personnel deliberations and vote.

# 6. VOTING PRIVILEGES OF PERMANENT/TENURE TRACK FACULTY:

All non-emeriti/ae Academic Senate faculty members within the Department of Design participate in personnel deliberations and vote.

## 7. VOTING PRIVILEGES OF EMERITI/AE FACULTY:

Emeritus faculty are not considered voting peers on any action.

#### 8. VOTING PRIVILEGES OF PHASED RETIREMENT SENATE FACULTY:

All Academic Senate faculty members on phased retirement have full voting rights on personnel and other departmental concerns.

## 9. VOTING PRIVILEGES OF LECTURERS, SOE/SR. LECTURERS, SOE:

All Lecturers with SOE, and Sr. Lecturers with SOE who hold faculty appointments in the Department of Design have voting privileges on all academic personnel actions.
